Updated Official Call to the February 26th, 2026 County Endorsement Convention

February 5th, 2026

To All Kalamazoo County Precinct Delegates:

Official Call to the Kalamazoo County GOP County Convention. There shall be a meeting of the duly elected Precinct Delegates and the At-Large Delegates to the County Convention at 7:00 PM Eastern Standard Time on Thursday, February 26th, 2026 at The Fountains Banquet Center, 535 S Riverview Dr., Kalamazoo, MI 49004. The purpose of this meeting shall be to elect Delegates and Alternates to the Saturday, March 28th, 2026 State Endorsement Convention to be held at the Suburban Showplace in Novi, MI.

The purpose of this meeting shall be to elect 39 Delegates and 39 Alternates, (and an additional 4 State At-Large Delegates) representing the 4th Congressional District portion of Kalamazoo County and 5 Delegates and 5 Alternates representing the 5th Congressional District portion of Kalamazoo County to the District Convention(s) held Saturday, March 28th, 2026 State Endorsement Convention to be held at the Suburban Showplace in Novi, MI..

The purpose of the State Convention is as follows:

1. The Endorsement of:
 - a) One (1) Secretary of State
 - b) One (1) Attorney General
 - c) Two (2) Justices to the Michigan Supreme Court
 - d) Two (2) members of the State Board of Education
 - e) Two (2) members each for the Wayne State University Board of Governors, the Michigan State University Board of Trustees, and the University of Michigan Board of Regents
2. The transaction of other such business as may properly come before the State Endorsement Convention.

For the purposes of the February 26th Official Kalamazoo County Spring 2026 Convention, the Kalamazoo County Precinct Delegates and Alternate Delegates to attend the State Endorsement Convention shall be apportioned to the following caucuses:

Those eligible to vote at this County Convention are: only duly elected Precinct Delegates and most recent Republican nominees for County and State Legislative offices, the incumbent Republican members of the State Legislature, the Michigan Congressional Delegation, the Statewide Officeholders, the Republican National Committeeman and National Committeewoman from Michigan and Michigan Republican Party Officers (see Rule 5B), the seven (7) State Committee members of each of the thirteen (13) congressional districts where such person resides, and Precinct Delegates elected to permanently fill vacancies at all subsequent County Conventions will be seated and considered eligible to vote on matters as may properly come before this County Convention.

Precinct delegates and certain at-large delegates given the preference under rule 8 of the convention rules, but who do not attend the county convention, must notify the Chair of the Kalamazoo County Executive Committee ([Chair](#)) or [Secretary](#) in writing (the "notification") of the person's intention to become a Delegate or Alternate Delegate to the State convention. The notification can be a letter or postcard to: KGOP, 5250 Lovers Lane, Suite LL110, Portage, Mi, 49002 or email to chair@kgop.us or secretary@kgop.us and must be received by the chair or secretary of the county executive committee at least (2) Two hours prior to the start of the County Convention. Failure to provide the notification as provided herein shall mean that the person shall not be given the preference under rule 8 of the convention rules. It is not necessary to send a notification if a person attends the county convention.

All business shall be in accordance with MRP 2026 State Endorsement Convention rules.

Note: Per RULE 17- FUNDING OF THE CONVENTION (MiGOP STATE ENDORSEMENT CONVENTION rules) "The [state] convention will be supported by: a. Precinct Delegate, Alternate and Guest \$50".
